

Newpeople Privacy Statement (2021)

Your privacy is of utmost importance for Newpeople. We would like to inform you via our Privacy Statement about the way we handle the collection of personal data.

Personal data that we process

Newpeople processes personal data about you because you use our services and / or because you provide this information to us yourself. Below is an overview of the personal data that we process:

- First and last name
- Other personal data that you actively provide
- Information about your activities on our website
- IP address
- Internet browser and device type

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us at hello@newpeople.nl and we will delete this information.

Why we need data

Newpeople processes your personal data for the following purposes:

- Newpeople analyzes your behavior on the website in order to improve our website and to tailor our range of products and services to your preferences.

How long we keep data

Newpeople will not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. You always have the option to delete your cookies either on our website or via the browser.

Share with others

Newpeople provides exclusively to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Mapping website visits

Newpeople only uses technical and functional cookies. And analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferred settings. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously saved via your browser settings.

View, modify or delete data

You have the right to view, correct or delete your personal data. You can send a request for access, correction or deletion to hello@newpeople.nl. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. We hereby ask you to black out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) in this copy. This is to protect your privacy. Newpeople will respond to your request as soon as possible, but within four weeks.
